# MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF CAIRO OF THE ARAB REPUBLIC OF EGYPT AND THE CITY OF SARAJEVO OF BOSNIA AND HERZEGOVNIA

The City of Cairo, the capital of the Arab Republic of Egypt, and the city of Sarajevo, the capital of Bosnia and Herzegovina, hereinafter referred to as "The two Parties",

Expressing their determination to enhance relations, ties of friendship, and cooperation between the two cities in the areas of culture, science, education, health, tourism, sports, environment, and commercial relations for the mutual benefit of the parties,

Have agreed the follows:

### Article 1

The two parties shall encourage the cooperation in the fields of culture, arts, and science through the exchange of delegations and expertise and the organization of exhibitions, festivals, symposiums and conferences.

### Article 2

The two parties shall encourage the cooperation in the field of education through the exchange of delegations and experiences to identify the culture and history of the peoples of the two cities.

### Article 3

The two parties shall encourage the cooperation in health and medical fields through the exchange of delegations, studies, experiences and participating in conferences held in both cities.

### Article 4

The two parties shall encourage cooperation in the field of sports, tourism, and youth—through the exchange of delegations and coordination of the participating delegations in relevant activities.

### Article 5

The two parties shall encourage the cooperation in the field of <u>solid waste</u> management and preservation of the environment through the exchange of experiences and delegations in relevant activities.

### Article 6

The two parties shall encourage the cooperation in the field of developing and strengthening commercial ties and relations through the exchange of experiences and delegations between members of chambers of commerce and coordinating the participation in relevant activities.

### Article 7

The two parties agreed that, in order to implement the aforementioned activities, the hosting party shall bear the local transportation and accommodation expenses only.

### Article 8

This Agreement can be amended by written consent between the Parties and shall enter into force with the same procedures on the basis with which this Agreement was signed.

### Article 9

In the event of any disputes may arise from the implementation or interpretation of any of the articles of this Memorandum of Understanding, it shall be settled through negotiation and consultation through diplomatic channels.

### Article 10

The Memorandum of Understanding shall enter into force from the date of its signature and shall remain valid for a period of five (5) years, and shall be renewed for another five years, through mutual consent from the two parties, unless one of the parties notifies the other —in writing— of its intention to terminate it at least six (6) months prior to its expiration date.
