Under Article 5 of the Decision on the requirements and method for awarding the "6th April Award of the City of Sarajevo" ("Official Gazette of the Canton of Sarajevo," no. 41/22 and 49/22), the Board for Awarding the "6th April Award of the City of Sarajevo" announces a

PUBLIC CALL

ON THE REQUIREMENTS AND METHOD OF NOMINATING CANDIDATES FOR "THE SIXTH OF APRIL AWARDS OF THE CITY OF SARAJEVO" IN 2023

In the City of Sarajevo, the City Council of the City of Sarajevo, activities are underway to prepare for the awarding of the "6th April Award of the City of Sarajevo" in 2023, on the occasion of 6th April, The Day of the City of Sarajevo.

The "6th of April Award of the City of Sarajevo" (from now on: Award) is awarded as the highest social recognition for significant achievements and outstanding work results in the areas of:

- economy,
- science and education,
- culture and art.
- sports,
- health and social protection,
- other areas of work and creativity,

regardless of the year of achievement, which contributes to the overall improvement, to the promotion, and development of the city of Sarajevo, as the capital of Bosnia and Herzegovina, and the Federation of Bosnia and Herzegovina.

Significant accomplishments, in terms of this decision, are actions and results achieved continuously which are considered as a contribution to the development of the respective area in accordance with the criteria common to the specific field and which contribute to the overall development, that is, the promotion of the city of Sarajevo.

The Award can be given to an individual or a team (a group of individuals gathered for the realization of specific tasks with results that can be considered in the nomination for the Award as significant achievements, i.e., outstanding if their achievements, that is, work results relate to the contribution to Sarajevo, private or public business company, institution, association and other legal entity from the city of Sarajevo, as well as those outside the city of Sarajevo, if their accomplishments, i.e., the results of their work related to the contribution to the city of Sarajevo).

A maximum of two awards, one individual and one collective award, can be given in one year, except in the case referred to in Article 17, paragraph (6) of the Decision on Amendments to the Decision on the Requirements and Method of Awarding the "6th April Award of the City of Sarajevo" ("Official Gazette of the Canton Sarajevo," number 49/22). The award can be presented to the same person, regardless of the category of the award winner, only once.

The award cannot be given to administrative bodies of all levels of government in Bosnia and Herzegovina, political parties, domestic and international political organizations, and foundations, elected officials, deputies,

or councilors of all levels of government in Bosnia and Herzegovina during their mandate, as well as to employees of the administrative bodies of all levels of government of Bosnia and Herzegovina for achievements related to activities within the scope of work they perform in the administrative body.

The award is presented **on April 6th** at the Ceremonial session of the City Council of the City of Sarajevo on the occasion of the Day of the City of Sarajevo and is delivered by the Mayor of the City of Sarajevo and the Chairman of the City Council.

Companies, institutions, **civil societies associations**, groups of at least 200 citizens, and other legal entities from the city of Sarajevo, as well as previous winners of the "6th of April Award of the City of Sarajevo", have the right to nominate candidates for the Award, with the fact that they do not have the right to put forward their own nomination for the Award. The Mayor of the City of Sarajevo has the right to nominate candidates for the Award.

The highest collective management body submits the proposal in accordance with the law or the highest legal act of that body and by the decision of that body on submitting a candidate proposal for the Award. The proposer is obliged to submit the candidate's written consent to accept the candidacy for the proposed field, as well as an extract from the current law or the highest legal act proving that it is the highest collective management/administrative body.

The candidacy proposal is submitted in two (2) copies, with detailed information, explanation, and necessary documentation. The justification should contain information about the candidate, the total work record and special merits in the field for which the candidate is nominated for the Award. The proposal for candidacy also states that the individual is a citizen of Bosnia and Herzegovina and that the team operates or is registered to perform activities on the territory of Bosnia and Herzegovina.

In case a candidate is nominated by a group of at least 200 citizens, a list of citizens must also be submitted in writing, which must include: the full name and surname of the citizen, ID card number, and issuing authority from the city of Sarajevo, and the citizen's handwritten signature.

Interested entities are invited to submit their candidate proposals within 45 days from the date of publication of the Public Call on the official website of the City of Sarajevo, ending on Thursday, January 26, 2023, until 4:00 p.m, directly to the mailroom of the City Council of the City of Sarajevo or by mail to:

Proposals received by mail after the specified deadline will not be considered.
